- This dog is sold as companion quality and sold with "Limited" checked on the AKC and ASCA registration papers. "Limited" status will allow this dog to compete in all venues of the dog sport except being shown in the unaltered breed conformation ring.
- **This dog shall not be used for breeding.**
- This dog, to the best knowledge of **ALADDIN**, is in sound health and free from communicable diseases at the date of sale.
- Should this dog die for any reason after 72 hours from purchase, the Buyer is responsible for full payment of said dog. **ALADDIN** will replace said dog if it should die within 72 hours of being picked up by the buyer, from a proven pre-existing condition. If this dog should require veterinary care within this 72-hour period, **ALADDIN** agrees to pay for all reasonable veterinary expenses upon receipt of a statement from attending veterinarian that the disease or illness was contracted prior to this dog leaving the **ALADDIN** property. **ALADDIN** demands to be notified immediately should any illness or disease be detected so a decision may be made on how to proceed with the veterinary care. If **ALADDIN** is not notified **in advance** of treatment, **ALADDIN** will not be obligated to pay veterinary expenses. **ALADDIN will not** cover payments for veterinary care due to negligence, mistreatment or accident to this dog, or for regular veterinary examination or shots.
- This dog is guaranteed against severe Hip Dysplasia, that prevents this dog from living a quality life and requires this dog to be destroyed prior to the age of four (4). An OFA Evaluation (an x-ray taken by a qualified veterinarian and sent to the Orthopedic Foundation For Animals for grading) is required, after this dog attains 24 months of age and prior to 30 months of age, for guarantee to be honored by **ALADDIN**.
- This dog is guaranteed against severe hereditary Epilepsy that prevents this dog from living a quality life and requires this dog to be destroyed prior to the age of four (4). Written verification confirming epilepsy, from a qualified veterinarian, is required for guarantee to be honored by **ALADDIN**.
- If Buyer chooses to have this dog euthanized prior to the age of four (4), due to one of the hereditary defects stated above or any other debilitating hereditary defect (written verification from qualified veterinarian required), guarantee is valid only if **ALADDIN** is notified in advance. **ALADDIN** guarantees to replace this dog with a dog of equal or greater quality, same sex, same color, within a two (2) year period. Buyer will give **ALADDIN** this dog's registration papers and certification of humane euthanasia.

- All shipping costs for this dog or his/her replacement, for any reason, will be the sole responsibility of the Buyer.
- This dog's registered name shall contain **ALADDIN** at the beginning of the name. No other prefix or suffix will be used unless written permission from **ALADDIN** is obtained.
- Buyer agrees to contact **ALADDIN** if, at a future date, they are no longer able to care for this dog and need to re-home him/her. **ALADDIN** agrees to assist Buyer in the re-homing if at all possible.
- **ALADDIN RESERVES THE RIGHT** to reclaim this dog for any of the following reasons:
  - a.) Poor care of the pup/dog's physical health and/ or
  - b.) Improper fencing/chaining the dog to any object and/or physical brutality to the dog and/or
  - c.) It is realized the offspring of this dog are being sold in a retail store, puppy mill, or auction.
 If it should become necessary to reclaim this dog for any reasons, there will be no compensation to the Buyer and all registration papers and rights of ownership will be released by the Buyer to **ALADDIN**.
- **ALADDIN** will supply the Buyer with shot/worming records of this dog.
- If either party is forced to take legal action to enforce any part of this contract, action shall be initiated in the county of the Breeder's residence, and any legal fees and court costs shall be the responsibility of the party found to be in default.
- **ALADDIN reserves the right to fine the buyer \$1500.00 or repossess said dog if a breach of contract occurs.**
