## Stud Service Agreement



We hereby signify Agreement to the terms and provisions prescribed below for the mating of:

### **THE OWNER OF THE BITCH AGREES TO:**

- Provide the stud dog owner with:
  1. 5 Generation pedigree
  2. O.F.A. evaluation (copy)
  3. Current eye exam report, dated less than 1 yr. from breeding date. (copy)
  4. Brucellosis test report
  5. ASCA/AKC registration papers (copy)
  6. Certificate of any titles earned. (copy)
- Keep the bitch confined while in heat and assure she is not bred with any other stud dog. A mis-mate breeding before or after stud service would cancel stud service agreement. Stud fee is not refundable.
- Notify the stud owner within 48 hours after the bitch whelps, or within a week after due date if no litter is whelped.
- If there are any mis-marked pups, they will either be culled from the litter in a humane manner or placed into companion homes on spay/neuter contracts. Solid (Lethal) whites will be culled in a humane manner, no exceptions.
- Keep a written description of any pup that dies or is culled before the stud dog owner sees it. (Color markings, dew claws and tail length)
- Have the tails docked (if not a natural bob) and dewclaws removed (if present) from all pups before the age of 4 days.
- Sell all puppies on a written contract, preferably with a spay/neuter clause and the registration papers checked "Limited" when sold as companion quality.
- Provide a complete list of buyers (including addresses and phone numbers) for the stud dog owner's records.
- No puppies shall be sold in any pet stores, retail or wholesale outlet.
- Additional veterinary costs for any artificial insemination or estrus testing will be passed on to the Bitch Owner. Bitch Owner agrees to pay for any estrus testing should Stud Owner feel such testing is warranted due to the fact that the bitch will not stand or more than one bitch is being mated to the Stud.
- If applicable, a boarding fee of \$5.00 per day will be assessed by Stud Owner beginning on the 5<sup>th</sup> day of boarding. The same will apply if the bitch is sent back for re-breeding.

**IN RETURN THE STUD DOG OWNER AGREES TO:**

- Provide the owner of the bitch with:
  1. 5 generation pedigree
  2. O.F.A. evaluation (copy)
  3. Current eye exam report, dated less than 1 yr. from breeding date. (copy)
  4. Brucellosis test report
  5. ASCA/AKC registration papers. (copy)
  6. DNA Analysis (copy)
  7. Certificate of any titles earned. (copy)
- Keep the bitch confined while visiting the stud dog, and assure that she is not bred with any other stud dog.
- Guarantee a minimum of two (2) live, properly colored pups after culling (according to the ASCA and AKC Breed Standard). If the breeding results in two (2) pups, naturally or by culling, the same bitch may return for a breeding within 18 months, at the same fee and terms.
- Sign any ASCA/AKC registration documents that are necessary for the registration of the litter (if all terms above have been satisfied).
- Stud Owners will take every reasonable precaution to ensure the safety and well being of the "Bitch", but will not be held liable for any sickness, accident, injury or death of said Bitch while in the care of Stud Owner.

**STUD FEE AND TERMS**

Stud fee is: **\$1200.00**

If stud fee is cash amount, it is payable at the time of the breeding. If stud fee is a pick puppy back, the decision will be made at 8 weeks of age.

I hereby understand that by completion of this stud contract, my bitch is not approved until the owners of the stud dog have fully executed this contract and returned a copy to me.

By signature below, all parties named herein agree to and are bound by the terms as set forth above. Should any legal action be necessary to enforce any terms of this Stud Contract, suit shall be filed in the county and state of the Stud Owners residence.
